

## PREVAILING WAGE ACT RESOLUTION

WHEREAS, the State of Illinois has enacted "An Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, county, city or any public body or any political subdivision or by any one under contract for public works," approved June 26, 1941, codified as amended, 820 ILCS 130/1 et seq. (1993), formerly Ill. Rev. Stat., Ch. 48, par. 39s-1 et seq. and

WHEREAS, the aforesaid Act Requires that the Manhattan School District 114 of Will County investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of said Will County employed in performing construction of public works, for said Manhattan School District 114.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF MANHATTAN SCHOOL DISTRICT 114:

SECTION 1: To the extent and as required by "An Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, county, city or any public body or any political subdivision or by any one under contract for public works," approved June 26, 1941, as amended, the Prevailing Wage Act, the general prevailing rates of wages in this locality for laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of the Manhattan School District 114 is hereby ascertained to be the same as the prevailing rates of wages for construction work in the Will County area, as determined by the Department of Labor of the State of Illinois as of June of the current year, a copy of that determination being attached hereto and incorporated herein by reference. As required by said Act, and any and all revision of the prevailing rates of wages by the Department of Labor of the State of Illinois shall supersede the Department's June determination and apply to any and all public works construction undertaken by Manhattan School District 114. The definition of any terms appearing in this Resolution which are also used in aforesaid Act shall be the same as in said Act.

SECTION 2: Nothing herein contained shall be construed to apply said general prevailing rates of wages as herein ascertained to any work or employment except public works construction of the Manhattan School District 114 to the extent required by the aforesaid Act.

SECTION 3: The Manhattan School District 114 Clerk or Secretary shall publicly post or keep available for inspection by any interested party in the business office of Manhattan School District 114 this determination or any revision of such prevailing rate of wage. A copy of the determination or of the current revised determination of the prevailing rates of wages then in effect shall be attached to all contract specifications.

SECTION 4: The Manhattan School District 114 Clerk or Secretary shall mail a copy of this determination to any employer and to any association of employers and to any person or association of employees who have filed their names and addresses and have requested copies of any determination stating the particular rates and the particular class of worker whose wages will be affected by such rates.

SECTION 5: The Manhattan School District 114 Clerk or Secretary shall promptly file a certified copy of this Resolution with the Secretary of State of the State of Illinois and the Department of Labor of the State of Illinois.

SECTION 6: The Will County Regional Office of Education shall cause to be published in a newspaper of general circulation within the area a copy of this Ordinance, and such publication shall constitute notice that the determination is effective and that this is the determination of this public body.


